Between:

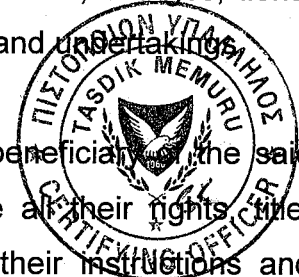

WHEREAS

The Assignor as beneficial owner assigns to the Assignee all such other benefits and interest for the absolute benefit of the Assignee.

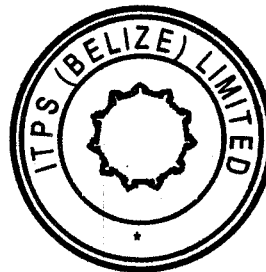
